### Saint John of God Housing Association Nominated for Prestigious Community Housing Award by the Irish Council for Social Housing.

It is my pleasure to announce that SJOG Housing Association was shortlisted by the **Irish Council for Social Housing** ("ICSH") for 'The Laurels'; a housing development located in Celbridge, Co. Kildare in the category, "Housing for People with Disabilities". Approximately 30 housing schemes were shortlisted for the prestigious biennial ICSH Allianz Community Housing Awards which took place on the 10th October, 2019 in County Wexford.

The **ICSH Community Housing Awards**, sponsored by Allianz, is a biennial competition that celebrates trailblazing excellence within the social housing sector and showcasing housing quality, innovation and partnership. The awards serve to demonstrate that approved housing bodies and local authorities are continually making efforts to meet high levels of housing demand and that good housing is the cornerstone to building diverse, sustainable and inclusive communities.

Dr. Donal McManus, Chief Executive of the ICSH said recently in a press release dated September 23rd that the "The Laurels is a wonderful example of high quality, energy efficient and sustainable housing built in a very beautiful setting. Saint John of God Housing Association leads in the provision of special needs housing in Ireland, as well as promoting the rights of people with specific needs to live independently".

Bernie Cadden, Chief Executive Officer of Saint John of God Housing Association said that "We are delighted to receive this worthy recognition by the ICSH for our creative and innovative housing design. In keeping with SJOG's vision, The Laurels will enable individuals to live and participate in the community with supports, so that they may reach their full potential."


## **Tenant Satisfaction Survey Results**

Saint John of God Housing Association conducted a Tenant Satisfaction Survey in May 2019. This was posted to 334 tenants and we received 116 completed surveys, which is equivalent to a 35% response rate.

The survey was the first nationwide appraisal conducted by the Housing Association from which we collected the tenants' views on topics such as rents, management fees, repairs and tenant engagement.

All questions were specifically designed around the services provided and were presented in an easy-to-read format. Questions only required check box responses and only a few asked for comments to enhance their answers.

Only named tenants were asked to complete the survey, and they could ask a staff member to help, if required.



## **Tenant Handbook and Easy-To-Read Guidance Notes**

It is with great pleasure that we announce that our new Tenancy Agreement is in circulation since July 2019. With our new Tenancy Agreement, there is an Easy-To-Read Guidance Note to help tenants understand the complexities of the Tenancy Agreement.

Likewise, we have also ensured that a new Tenancy Handbook accompanies the new Tenancy Agreement, and it too has an Easy-To-Read Guidance Note. Eimear, our Housing Officer, will be coming to you to ensure that you receive a copy of the Handbook. In addition, she will play a service user lead video which explains the tenancy handbook. Eimear is looking forward to seeing you soon.

#### An Opportunity to have your Say – Tenant Forum

We have made a commitment to establish a forum to ensure that the voice of our tenants is heard and considered. We are establishing a Tenant Forum in 2020, which will comprise Saint John of God Housing Association staff and tenants. The forum will deal with the following:

- Improving the services to our tenants
- Tackling issues affecting our tenants
- Involvement in Community events
